3. Nomination papers may be obtained from the offices of the Returning Officer, Castle House, Barracks Road, Newcastle-under-Lyme, Staffordshire, ST5 1BL during the times stated above.
4. If any election is contested the poll will take place on **Thursday, 20th June 2024.**
5. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight, on the 4th June 2024.** Applications can be made online: <https://www.gov.uk/register-to-vote>
6. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Castle House, Barracks Road, Newcastle-under-Lyme, Staffordshire, ST5 1BL by **5 pm on Wednesday, 5th June 2024** . You may apply online or download a form at <https://www.gov.uk/apply-postal-vote> or contact the Electoral Registration Office direct.
7. Applications for a Voter Authority Certificate (free voter ID, or an Anonymous Elector's Document valid for this election, must reach the at Castle House, Barracks Road, Newcastle-under-Lyme, Staffordshire, ST5 1BL by **5 pm on Wednesday, 12th June 2024.**
